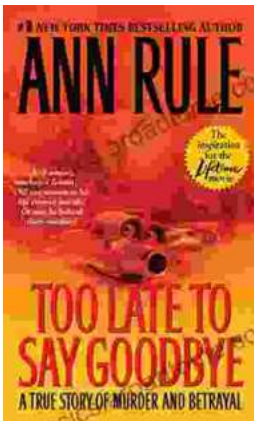
 Scales of justice representing Texas Small Claims Court

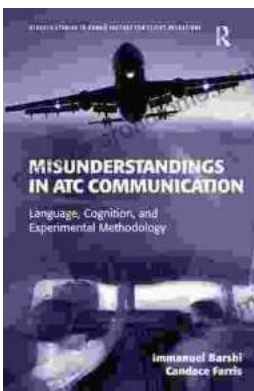
